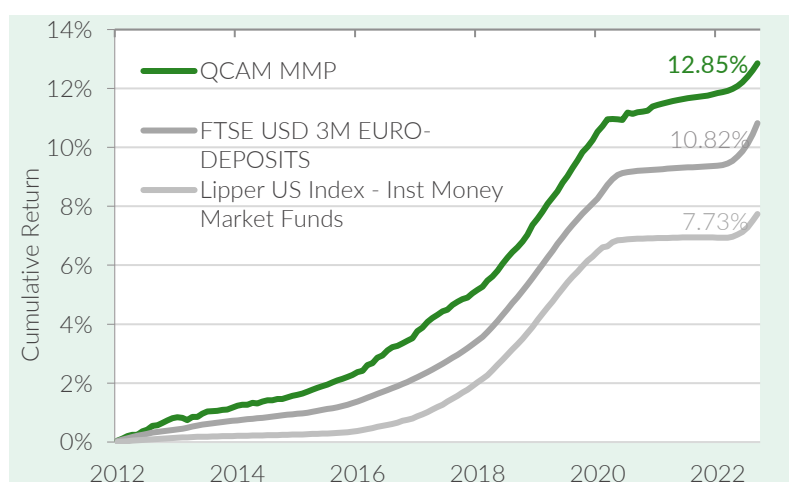

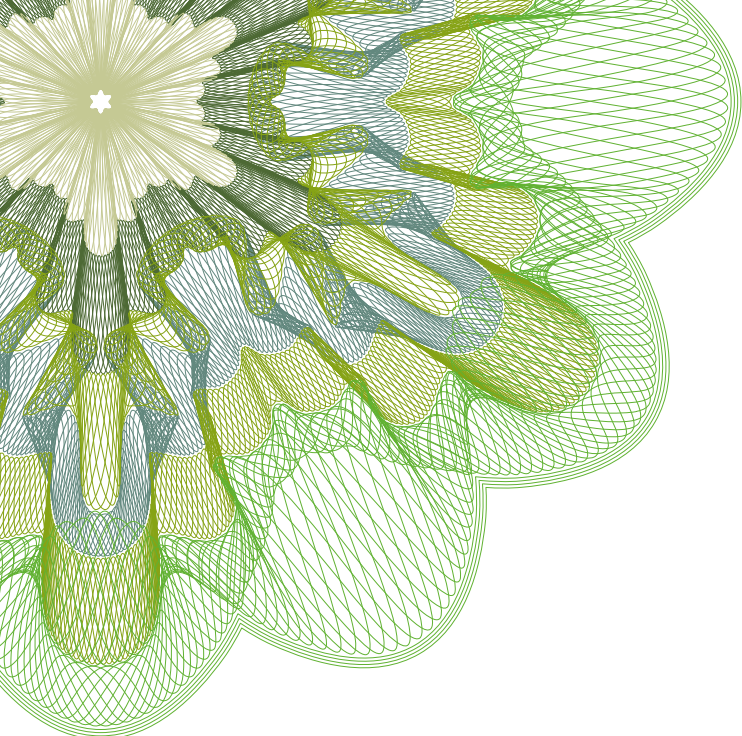
QCAM MMP vs. Benchmark Returns (As per September 2022)
